THE PRESIDENT'S REPORT

Where did the fall go? I asked myself the other day when I left my office to run a mid-day errand. This time of year, I often get in before the sun is very high or before it is up at all and leave when it is dark. It was strange to be out on a warm sunny late October day, but found myself admiring the bright red, orange and yellow colors of the leaves in Western New York that I have seemed to have missed over the past few weeks. October is the crossover month for intercollegiate sports. It is during this time that we often just keep our heads down and push through this tough stretch just to take a breath on the other side after the fall sports have ended. As we turn our calendars to November, we will also need to "fall back" and turn our clocks back one hour to Eastern Standard Time. It is the only time of year we get a 25-hour day, use it wisely. While many of us use it to catch an extra hour of sleep, if you get a chance, maybe admire some of the beautiful fall foliage that New York State has to offer.

Since our last newsletter, some big things have happened. One monumental item was the signing into federal law the Sports Medicine Licensure Clarity act on October 5, 2018. If you are an AT that travels with your athletes or teams across state lines, this law is meant to help protect you. As quoted from the NATA briefing: "Under the Sports Medicine Licensure Clarity Act, health care services provided by a covered sports medicine professional to an athlete, athletic team, or a staff member of a team outside of his or her home state would be deemed to have occurred in the professional's primary state of licensure." In other news, we received word this past week that the NYSATA will receive a NATA Legislative Grant of \$37,800 for 2019. This grant is critical in continuing our efforts toward AT licensure in NYS. I would like to thank our Governmental Affairs co-chairs, Aimee Brunelle and Deanna Errico, for coordinating the efforts with our lobbyist, Karin Carreau, in this continued pursuit of AT licensure.

In NYS, legislative bills have a 2-year life cycle. Since our AT licensure bills failed to move forward this past summer among political dysfunction in Albany, new AT bills will need to be introduced in both the Assembly and Senate in January 2019. Since the entire NYS legislative body is up for grabs on Election Day next week, we will be eagerly waiting to hear the results so we can finalize our strategy for the legislative cycle beginning in January. Stay tuned as we will need you to engage at the grassroots level.

Mentioning those two items above, made me think about the [NATA Liability Tool kit](#). This online tool is designed to "...make sure athletic trainers, administrators and insurance providers are on the same page when it comes to proper liability coverage." This tool will help you identify and or highlight any particular liability issues of concern at your place of employment. Some issues may require immediate attention, whereas others may need to be brought up for consideration in the next budget year. Depending on your employer's fiscal cycle, some budget meetings may occur as early as January or February 2019. You can find the NATA Liability Took Kit on [their website](#).

Another big item to take place this fall was NYS Athletic Trainer Recognition week held October 5 – 14. I hope you took advantage and had an announcement or PSA read at a home event or participated via social media posts. We ATs, by the very nature of what we do behind the scenes, often do not crave the spotlight. However, we do need to take the opportunities when they are there to have your contributions and services recognized and promoted.

To our members that are working at the secondary school level, we have added an ATLAS tab on the [NYSATA website](#). The Athletic Training Location And Services (ATLAS) initiative is to have 100% of NYS secondary schools complete the survey. We hope that this gives our members an easier opportunity to view if ATLAS has your school up-to-date or if your school still needs to submit a survey. Please go to see if your school is listed as "have not completed" or needing to "re-take" the ATLAS survey. There is a [link on the page](#) that will take you to the survey.

For students, do not forget to apply for scholarships and or available leadership positons.

Governmental Affairs Report

Thank you to all those athletic trainers who continue to be active politically, and we encourage everyone to vote this month in the election. History has certainly shown us the importance of each vote. We hope you have been able to communicate with your local legislators and have been following the local races. The upcoming legislative session is a bit of unknown territory until after this election. It may be that our Republican sponsored bill will become a lower priority if the senate moves to

democratic, or will become more difficult to pass. We may have some positive connections with Democratic senators resulting in a push of our bill. We do know that Senator Funke, our bill sponsor, has earned respect in the senate when his bill S4375A passed the senate and the assembly (waiting for the governor to sign) that will allow physicians traveling with teams from out of state to practice if they are licensed in their state. We are hoping to continue with the momentum on that win and to replace some of the language in our bill with the physician's bill language.

At the end of this summer, Deanna, Aimee and Karin, our lobbyist, met with the State Education Department to review our bill. This was a really great step for us, as SED helped us recognize language that could be better if altered and allowed us to help explain what we meant in areas of the bill. Currently we are working to adapt the language for our bill based on their feedback.

We have great things to celebrate with the physician's bill passing and on the national front with the NATA's efforts on the Sports Medicine Licensure Clarity Act ending up with the bill passing and being signed by the president on October 5 of this year. This legislation will provide added legal protections for sports medicine professionals (including athletic trainers) when they are traveling with professional, high school, college, or national sports teams. A really positive step for athletic trainers everywhere, including in New York State.

Another great step this year was the addition of athletic trainers to the Ironman bill (S7439A) sponsored by Senator Betty Little. This allows health care professionals to perform services at the Ironman competition in Lake Placid and this is the first year that athletic trainers were added to that bill, thanks to efforts from NYSATA (this bill was signed in July 2018 and athletic trainers should be in all future Ironman bills).

It seems these are signs that the athletic trainer's skills are being recognized, appreciated, and valued, and we hope to see more of this, and that this finally results in passage of our bill in 2019.

However, the upcoming election will tell us a lot. We have been in a holding pattern, while waiting for this election, with efforts by the NYSATA Government Affairs committee this fall of continued communication with specific legislators.

Once the election is complete, NYSATA Government Affairs can begin again to more actively engage with legislators and will be able to guide our members in their approach to legislative action.

NYSATA Legislative Update

As I have reported in the last two quarterly articles, the political landscape has been shifting like tectonic plates in Albany for the last several months and given the 7.6 Richter scale rating of several primary races, the stage is set for high drama come Election Day. While the Governor handily fended off an attack from the left (garnering 65% of the vote), his challenger, actress Cynthia Nixon appears to have shifted his platform

askew from his historical “center” as his positions on issues such as the legalization of marijuana and single payer healthcare have dramatically evolved over the course of the campaign. Though we might have expected a drift back toward middle for the general election, the electorate’s appetite for progressive policies seems wetted and therefore bolstering his numbers going into the November 6 race against Republican nominee Marc Molinaro.

As the Governor easily cruised to victory in his primary race, his Lieutenant Governor, Kathy Hochul experienced some nail-biting moments as early results showed her race against New York City Councilman, Jumanne Williams to be close. In the weeks leading up to Primary Day, the race garnered the attention of political wonks for the ever-tightening poll numbers and the historical value of a Governor being faced with a Lt. Governor not of his choosing. However, final results called the race for Hochul with 53 percent of the vote.

The closely watched race for Attorney General made history with a win for Tish James, the first African American woman nominated to run for NY State’s Attorney General. In the days leading up to Primary day, polls in this tight race reported NYC Public Advocate, James, to be neck and neck with Congressman Sean Patrick Maloney, with perennial candidate Zephyr Teachout, within striking distance. However, 90 minutes after polls closed, with 83 percent of precincts reporting, James was called as the victor with 41 percent of the vote. She will now face off against Republican nominee, Keith Wofford, a graduate of Harvard Law School and partner in a New York City-based law firm. The last time New York elected a Republican Attorney General was 1994 with Dennis Vacco, who would serve one-term, losing re-election in 1998 to Eliot Spitzer.

The excitement of the evening was to be realized with the State Senate Primary Races. Despite promises by mainline Democrats that members of the Independent Democrat Conference would not face primary challenges following their reunification with the Democratic Conference in April, every member faced a primary race and 6 of the 8 went down in dramatic fashion. While Marisol Alcantara’s race (31st District) was the first of the evening to be called for challenger Robert Jackson, a former New York City Councilman, former IDC Leader, Senator Jeff Klein’s stunning loss in the 34th District was perhaps the biggest news of the evening.

Spending nearly \$2.5 million against insurgent and eventual victor, Alessandra Biaggi, an attorney and former Clinton staffer, Klien lost his long-held seat 53-47. Soon after, four of his fellow allies fell as well. Senator Tony Avella (11th District) lost his rematch against John Liu, former New York City Comptroller and New York City Councilman with a final vote tally of 50-45 (though he has recently announced he’ll make a third-party run). Senator Jesse Hamilton (20th District), a former co-sponsor of the AT Licensure Bill, was defeated by Zellnor Myrie, a Brooklyn lawyer.

Senator Jose Peralta lost to former DeBlasio staffer, Jessica Ramos in the 13th Senate District, 50 – 41. Ramos described herself as a community organizer, union advocate and daughter of parents who emigrated to the U.S. from Colombia, some of which was disputed by her family. Former upstate IDC member, Senator Valesky was trounced in the 53rd District, 66-33 against Rachel May, a former high school math teacher and college professor of Russian literature. For weeks following Primary Day, Valesky mulled a third-party run, however, he has since decided against it.

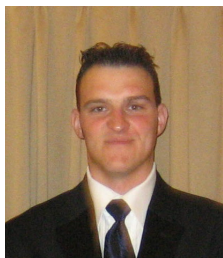
The only two remaining former IDC members to have survived were Senator Savino (Staten Island), who handily beat her opponent in the 23rd Senate District, 78 – 7 and Senator Carlucci who faced off against Julie Goldberg in the 38th Senate District, a former teacher and current librarian. Senator Carlucci won 51-44.

In Less Dramatic Races, albeit, impactful as well, the race in the 17th Senate District went to Senator Simcha Felder, the Democrat who has caucused with Senate Republicans since being elected in 2012. His party allegiance may be a hot commodity again in the 2019/20 session (depending on which way the Senate breaks). While in the 18th Senate District, newcomer Julia Salazar, a member of the Democratic Socialists of America, unseated longtime incumbent Senator Martin Dilan. Out west, in the 63rd Senate District – *Democratic incumbent Senator* Timothy Kennedy prevailed over Democrat Shaqurah Zachery, receiving 76 percent of the vote.

Another surprise of the evening was in the 18th Assembly District where Democrat Taylor Raynor defeated longtime Democrat and Deputy Speaker Earlene Hooper.

What does this all mean for NYSATA and our legislative efforts? Given the demographics of most of the former IDC seats and Democratic turnovers - the primary races were *the* races. This means, at a bare minimum, we will have quite a few new members to welcome, engage and educate about the scope of practice of Athletic Trainers, the vital role you play in your given area of practice and our legislative initiative to move from certification to licensure. Should NY, specifically the Senate (as some prognosticators are suggesting), be hit by a Blue tidal wave, and as a result, flip the Senate to a Democratic majority, we, along with all advocates, will be preparing for shift in Committee Chairs, key staff and priorities. Such a scenario will have us jockeying for attention among hundreds of initiatives. Your Government Relations Team is preparing for any outcome and has already crafted and begun to implement plans. However, your continued engagement is more important

than ever before. At the risk of sounding like a broken record, I would highly encourage you to make a district visit to each of your representatives, invite them to your field and/or athletic training room and ask for their support. In the meantime, your Albany Team will continue to pound the pavement in the capitol. Should you have any questions regarding engagement, please do not hesitate to reach out.

Greetings Secondary School Athletic Trainers!

I hope that your fall season is winding down smoothly and you are looking forward to a minor respite before the winter season

begins. As we close out 2018, the NYSATA Secondary School Committee would like to send a huge thank you for previously completing Athletic Training Locations and Services (ATLAS) Project Survey, a joint initiative of the Korey Stringer Institute, the NATA, and the NATA Secondary School Athletic Training Committee. More information about ATLAS can be found at the [KSI ATLAS Project](#), [NATA](#) and [NYSATA](#) websites.

During the past year, the ATLAS Project completed the Mapping Phase and they are proud to say that 100% of public and private schools throughout the United States (n= 20,272) are mapped. Now is the Annual Survey Phase. Currently, 50% (n= 6,754) of the schools with AT services (n= 13,473) have taken the survey previously, but only 642 schools have taken the survey this year.

So they can provide the most accurate data to your state leaders, they ask that the survey be taken annually between September and December. With ATLAS survey data for your school updated annually, they can continue to strive to accomplish the following goals:

- Create a real-time database of athletic training services in secondary schools
- Create a directory for each state's athletic training association and high school athletics association
- Assist states in moving toward full-time athletic training services
- Provide useful data to each state's athletic training association and high school athletic association
- Identify common factors associated with increased athletic training services across the country

What they are asking:

If you have not re-taken the [ATLAS Survey](#) since August 16, 2018, they ask that ALL ATs at your school complete it.

If you have changed schools, please email them to remove you from your old school and fill out the survey for your new school.

If you no longer work at a high school, please email them to remove you and in the email please indicate if you know if that school still has AT services and the name or contact of the new AT.

KSI will help you!

KSI has worked closely with the New York State Athletic Trainers' Association to ensure they have accurate information regarding our athletic trainers. This information is a tremendous step towards creating awareness about the importance of ATs, assisting with legislative initiatives, and making positive change to protect high school athletes.

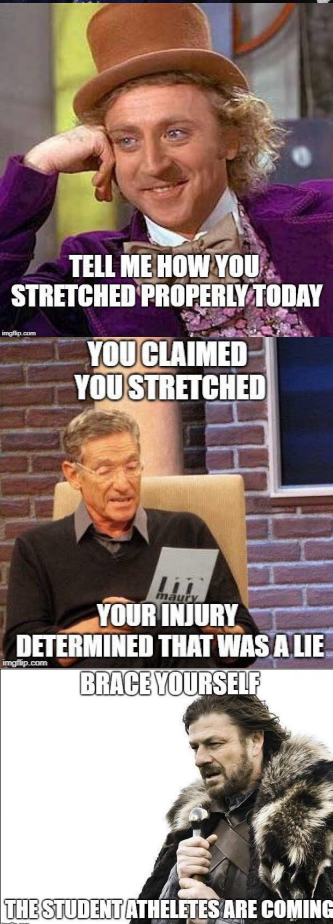

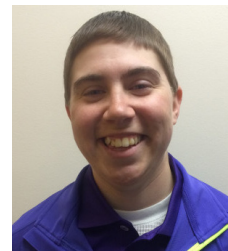

Athletic Training Program Awarded Diversity Grant

Clinical Instructor Katie Sheehan, MS, ATC, and Professor Paul R. Geisler, EdD, ATC, of the Athletic Training Education program in DESS, were recently awarded a modest diversity enhancement grant by the National Athletic Trainers' Association Ethnic Diversity Advisory Committee (NATA EDAC). Submitted on behalf of the AT Program's EquAT and InclusivAT programming, with the help of several current Athletic Training students, the grant will fund a unique program involving Ithaca High School students during the coming academic year.

The NATA EDAC serves in an advisory capacity to the Board of Directors, aiming to identify and address issues relevant to the ethnically diverse populations to better serve the needs of both patients and fellow athletic trainers. EDAC advocates sensitivity toward cultural diversity, development of cultural competence within the profession and promotion of athletic trainers as leaders in issues related to cultural competence and professional diversity within the health care professions. It has made planning grants available to educational institutions seeking to enhance ethnic diversity within the profession.

The grant awarded to the IC AT Education Program and its EquAT and InclusivAT program was awarded under Category 1, as it is intended to recruit, retain and educate ethnically diverse athletic training students with the intent to increase the number of ethnically diverse certified athletic trainers. Current senior Athletic Training students, Katie Dolan, Jennifer Gordan, Shelby McDavid, Tony Cosby, and Niklas McKone, were instrumental in conceiving and constructing the grant proposal, and will be central to implementing the program this year.

The grant funds the formation and implementation of an athletic training club for interested minority students at Ithaca High School in coordination with their certified athletic trainer. Members of the club will attend AT classes and workshops at IC to learn more about sports medicine, and the athletic training profession. They will take part in pre-game, game, and post-game athletic training duties with Bomber Athletics Events and certified athletic trainers. They will also experience how athletic training roles differ in the Division 1 environment by attending events and athletic training clinics at Cornell University and Syracuse University.
